**Question: Do you have any sales history and/or commission reports from the current vending service?**

*Answer: We do not have any sales history on the current vending service. Listed below is a listing of the commissions paid to SARTA by the current vending service. Our current vendor is paying a commission of \$.05 (five cents) per soda machine sale.*

*October 1, 2008 to December 31, 2008 - \$325.50*

*January 1, 2009 to March 31, 2009 - \$315.05*

*April 1, 2009 to July 3, 2009 - \$ 344.95*

*August 1, 2009 to October 31, 2009 - \$371.30*

## VENDING SERVICE AGREEMENT

**THIS AGREEMENT** is made the 24th day of November, 2001  
by and between SARTA (location)  
and VendPro, Ltd. (Vendor).


**WHEREAS**, Location desires quality vending service for its employees and customers.

**WHEREAS**, Vendor has the capacity and the knowledge to provide said service.

**NOW, THEREFORE**, both parties agree as follows:

1. Location agrees to allow Vendor to exclusively provide vending machines upon location's business premises subject to the terms and conditions of this agreement.
2. The term of this agreement shall commence on November 24 Th., 2001, and shall continue until November 23, 2003. Following the expiration of the term, the agreement will be automatically renewable for additional one year periods unless notice in writing is tendered between ninety (90) and thirty (30) days prior to the expiration of the agreement or any subsequent renewal thereto.
3. Vendor shall be responsible for installing and maintaining vending equipment which reasonably meets the location's needs. Vendor shall remain the sole owner of all such equipment. Location shall provide all utilities including necessary water and electrical lines. Location shall also dedicate appropriate space for vendor's equipment which is designed to maximize access to the units by both their users and by employees or agents of Vendor who service the units. Both parties hereto shall be responsible for loss or damage to their respective property.
4. Vendor reserves the right at time during this agreement to alter the units presently located at the premises of location or to remove all units if, in its sole discretion, it is determined that vending cannot be properly maintained.
5. This agreement is assignable by either party without notice.
6. Vendor will pay 0 % of the Net Sales taken from the machines at the location.
- \* 7. Vendor will pay .05 Per soda machine sale in accordance with SARTA's Mandate. To be paid to the Employee Relief Fund.
