Streetcar Presentation

- Ridership continues to slowly increase.
- The new bid began May 15, 2022.
- There has been an axel supply issue for the seven (7) Gillig buses. SARTA expects possession of the buses in June or end of July.

Finance (Carrie Domer)

• The 2021 Federal Triennial Audit will be June 13-27, 2022. This audit will be conducted virtually.

Development & Special Projects (Clayton Popik)

- Construction documents from Bowen are expected in June from Omnipro.
- Wayne County work trips was the highest last month at 429 trips.
- Mr. Popik attended the APTA Mobility Conference in Columbus, Ohio.

Customer Relations (Latrice Virola)

- Score cards will go live to the public July 11, 2022.
- The paper Touchdown Cards will not be available as a 31-day pass.
- Marketing material will focus on how to obtain and use the Score Cards.

Information Technology (Craig Smith)

• SARTA is on target with Genfare installation and will be active in July.

Human Resources (Tammy Marie Brown)

• SARTA will host two (2) college students this summer from the University Minority Internship Program.

Communications from Executive Director/CEO

- The Ohio Clean Hydrogen Alliance, founded by SARTA, joined the World Economic Forum's Industrial Cluster Decarbonization Effort. The goal of the effort is to reduce CO2 emissions in 100 clusters around the world.
- SARTA continues to work with a staffer from Sherrod Brown's office concerning the Massillon Transit Center.

Mr. Warren moved to adjourn the meeting at 6:46pm. Mr. Morey seconded the motion.



Massillon Transit Center


We have received the construction documents from Bowen and Omnipro is currently reviewing them for any issues prior to going to bid. We submitted our full NEPA document for the property on Tommy Henrich Dr. to the FTA for review.

Gateway Site

Grading of the training pad and parking lot expansion occurred in May. The driveway was also dug and has begun making its way around the north side of the building. We continue to coordinate efforts with Dominion to relocate the 8" pipeline running through the site. Once moved, this will allow Stanley-Miller full access to complete the sitework project. Concrete is expected to be poured in mid-June for the training pad while grading and base preparations continue for the new parking lot. Perimeter fence installation has also begun. AT&T completed a fiber optic line relocation and pole installation to ensure this service did not conflict with the new roadway.










Transportation Contracts

SARTA Revenue Fleet Farebox Replacement & Upgrade Project

Project Description and Scope: SARTA is currently using an older GFI fare collection system which has reached the end of its useful life. SARTA relies heavily on this system for not only fare collection, but also as the primary method of reporting ridership and transaction data. The main objective of this project is to completely replace the current system with a reliable, cash-processing fare collection system.

The current fare payment and collection system utilized by SARTA is built around the Genfare Odyssey farebox system and Ticket Reading and Issuing Machine (TRiM) units that issue and read a variety of magnetic barcode fares and transfers, as well as, accepts cash and coin. The current system is 14 years old and will need to be replaced in the near future. SARTA is exploring opportunities to not only replace the existing system, but to also expand options for making payments by means other than cash.

Project Status: This SARTA Revenue Fleet Farebox Replacement project is composed of multiple phases.

<u>Phase 1:</u> consisted of replacing the Odyssey fareboxes with the new Fast Fare fareboxes. Along with the fareboxes all associated production garage computer equipment [probe, test unit, network manager, and fare collection vault] was also replaced. After an initial, successful pilot of twelve (12) buses, the remaining buses were installed with the new Fast Fare fareboxes and Phase 1 was completed on May 30, 2020.

<u>Phase 2:</u> consists of setting up the ticket vending machine (TVM). The TVM will be located at the Cornerstone Transit Center. The TVM will be configured and setup to sell and reload the new SARTA fare media. When the Ticket Vending Machine (TVM) goes into production, Phase 2 will be complete.

<u>Phase 3</u>: includes Smart Card branding, configuration, setup and implementation of Administrative Point-of-Sale (APOS) / Retail-Point-of-Sale (RPOS) equipment. The APOS is a touch screen computer with built-in receipt printer that will simplify SARTA customer support representative's task of selling or encoding smart cards at SARTA transit centers. SARTA APOS also includes a smart card printer and camera that will allow the rider to have their picture on their smart card. RPOS is a terminal in which customers may make purchases or add value to their existing smart card at a retail location that SARTA partners with, such as grocery stores or local banks. Phase 3 also, includes establishing Genfare Link and completing testing. Phase 3 will end when Genfare Link goes live with new configuration that will be decided upon given SARTA's model and is accepted by SARTA.

SARTA Revenue Fleet Farebox Replacement & Upgrade Project (cont'd)

Currently, we are finalizing the User Acceptance Testing (UAT) and will begin to move into the pilot/production phase. There are various intricate issues that are being addressed with regards to TVM, fare structure, and financial reporting. We have received all of the SCORE Cards and are awaiting the arrival of the Limited Use Cards that are on back order due to supply chain issues. The expected date is in April 2022. Also, after including the new Wayne County fare into the fare structure, User Acceptance Testing was push out further to accommodate testing of that particular fareset. Therefore, SARTA is enter into pilot/production by June 20, 2022.

- Score Cards will be active on fareboxes starting Monday, June 27th for employees/staff.
- SCORE Cards will be launched publicly, Wednesday, July 13th.

Installation of JRV Validators for EZFare

Project Description and Scope: SARTA will begin outfitting their revenue fleet with JRV validators that will authenticate SARTA riders who use the EZFare app for bus fare. Currently, riders show their phone to drivers for visual validation in order to board the bus. This process is tedious and can lead to riders boarding with 'faked' fare, such as screen shot image or a screen recording of an old EZFare QR code.

After the JRV validators are installed, the rider will place their smartphone up to the validator's bar code scanner and it will authenticate the rider's fare and announce with a loud audio beep and a green check mark for OK, or a loud buzz and red X for Not OK. The JRV Validator will only allow those fares that are current and valid to work, thus alleviating the risk of any 'faked' or phony EZFare QR Codes.







More Industrial Hubs to Accelerate Their Net-Zero Transition

Four leading industrial clusters in the Netherlands, Belgium and the US today announced that they are working together with the World Economic Forum to reduce their carbon emissions faster through the Transitioning Industrial Clusters towards Net Zero initiative.

Launched at COP26 in November 2021, the initiative aims to accelerate the decarbonization of hard-to-abate industrial sectors, while maximizing job creation and economic competitiveness. The approach focuses on building cross-industry and cross-cluster partnerships to better implement low-carbon technologies – as in the case of the regionally developed Basque Hydrogen Corridor – and on accessing public funding and blended-finance options for clusters' decarbonization projects.

Under this initiative, the World Economic Forum, working closely with Accenture and the Electric Power Research Institute (EPRI) as knowledge partners, connects private and public stakeholders to assess how to meet individual and collective decarbonization goals, fosters new enabling policies and provides guidance and support for local community engagement.

Industrial clusters are geographic regions where industrial companies are concentrated, making them an attractive target for impactful emissions reduction strategies. Since industrial assets are located in close proximity of each other, sharing of infrastructure (such as CO2 and hydrogen pipelines or renewable energy assets), financial and operational risks, and natural and human resources becomes possible. This also provides opportunities to deploy and scale new green technologies, such as hydrogen and the capture, utilization and storage of carbon for industrial applications, enabling a systemic approach to emissions reduction.

The clusters joining the initiative are:

- · **Brightlands Circular Space**, together with Brightlands Chemelot Campus, Chemelot, and the Chemelot Circular Hub in Geleen, Netherlands. It will help accelerate the energy transition and circular economy.
- **H2Houston Hub**, formed through the Center for Houston's Future and encompassing more than 100 organizations and companies. It will leverage the Houston area's position as the US's largest hydrogen producer and consumer, and use innovation and scale to reduce the cost of clean hydrogen and emissions.
- **Ohio Clean Hydrogen Hub Alliance**, with approximately 100 corporate, governmental and community organization members. It will lead the region's campaign to establish a clean hydrogen hub in the state of Ohio, US.

• **Port of Antwerp-Bruges**, Europe's second-largest port. It will drive the circular economy and energy transition.

These four large industrial emissions centres, involving oil and gas extraction and processing, shipping, heavy-duty transportation, chemicals and other sectors, currently account for CO2 emissions of 296 million metric tonnes per year – greater than the annual emissions of Poland. They employ more than 470,000 people and represent an annual gross domestic product (GDP) of \$135 billion.

"Supporting industrial clusters and corporate partners in the development and implementation of their net-zero strategies is at the heart of what we do," said Roberto Bocca, Head of Energy, Materials and Infrastructure Platform, World Economic Forum. "We are proud to leverage our collaborative platform and expertise in partnership building to grow the clusters initiative as well as other decarbonization efforts we support, such as the First Movers Coalition, Mission Possible Partnership and Clean Hydrogen Initiative."

The four new clusters join four others in the UK (Zero Carbon Humber and Hynet North West), Australia (Kwinana Industries Council) and Spain (Basque Net-Zero Industrial Supercluster), which were part of the initial launch of the initiative. Based on metrics provided by each cluster, all eight clusters could potentially save more than 334 million tonnes of CO2 – more than the equivalent annual emissions output of France. They could also create and protect 1.1 million jobs and contribute \$182 billion to regional GDP.

"The Ohio Clean Hydrogen Hub Alliance seeks to locate a clean hydrogen hub in the state of Ohio, leading to the eventual decarbonization of much of the transportation, electricity, industrial and heating sectors," said Kirt Conrad, Co-Founder, Ohio Clean Hydrogen Alliance and Chief Executive Officer, Stark Area Regional Transit Authority. "Investment into a clean hydrogen hub in Ohio will help create massive economic, environmental and health benefits for the state and its citizens."

"With our focus on becoming the premier circular ecosystem in Europe, it is of upmost importance that we foster competitive collaboration between the companies in our cluster as well as with other global clusters," said Lia Voermans, Director Brightlands Circular Space, "We believe that this initiative provides a gateway to access the best practices and processes supporting industrial decarbonization."

The new clusters are already actively advancing their decarbonization journey. For instance, the Port of Antwerp-Bruges is starting to convert hydrogen into sustainable raw materials and fuel for the port's chemicals sector, whereas the Ohio Clean Hydrogen Hub Alliance has developed hydrogen fuel cell buses which tour around the US, educating transit authorities on the potential and viability of clean transportation. However, to achieve net-zero emissions, these efforts must be scaled up. Often, financial mechanisms, rather than technology, are the main roadblock, and policy frameworks to support valuable future technologies are lacking. As value chains are transformed, the creation of new partnerships will be key.

"The Houston region has the talent, expertise and infrastructure needed to lead the global energy transition to a low carbon world," said Brett Perlman, CEO of the Center for Houston's Future. "Clean hydrogen, alongside carbon capture, use and storage are among the key technology areas where Houston is set to succeed and can be an example to other leading energy economies around the world."

"The Port of Antwerp-Bruges hosts Europe's largest chemical cluster and supports the European Green Deal to become climate neutral by 2050," said Jacques Vandermeiren, Chief Executive Officer, Port of Antwerp. "To reach this goal we will all have to work together with respect for individual company needs, industry characteristics and timing. The Transitioning Industrial Clusters towards Net-Zero initiative is a means to inspire and incentivize companies to share best practices in our common pursuit of staying well below 2°C."

In addition to the eight clusters currently involved in the initiative, more than a dozen in the US, Europe and the Asia-Pacific region are also in the process of joining. The aim is to build a community of 100 global industrial clusters to accelerate industrial decarbonization.

Transit agencies face hurdles in their efforts to decarbonize

Journalists, politicians, and business leaders boarded a light blue Stark Area Regional Transit Authority bus on a temperate late April afternoon in Downtown Columbus.

Rather than the vibrations and low grumble of a diesel engine, riders heard a soft whirr as SARTA Executive Director Kirk Conrad started the bus and took the massive vehicle on a quick spin around the Ohio Statehouse. The hydrogen fuel cell powering the bus made the smooth and largely silent running possible. SARTA has 20 emissions-free hydrogen buses in its fleet. The trip was a showcase for the Canton-area agency's plan to ultimately decarbonize its entire fleet.

The transit authority is hardly alone. Nearly every Ohio transportation agency has plans to reduce carbon emissions, a priority given that the majority of the nation's carbon emissions come from transportation. They face an uphill battle.

Public transportation "is one of the first places we can and should see mass decarbonization efforts," said David Cooke, senior associate director of Ohio State University's Center for Automotive Research.

Creating an environmentally sustainable transportation service, however, isn't easy or cheap. Hydrogen or electric battery buses save money in the long run, Cooke said, but years pass before an agency experiences those savings.

A 2019 report from the Environment America Research and Policy Center found the average price of a diesel bus is \$500,000, compared to roughly \$750,000 for an electric bus. The savings on gas and maintenance cost makes up the difference after five years, the report found.

Hydrogen fuel also comes from natural gas, which gives off carbon dioxide and methane, reducing their environmental benefits.

Most transit agencies in the Buckeye State plan to use electric buses to reach sustainability, but buses that run on electric batteries come with complications.

COTA put two electric buses in service last year (in a fleet of more than 300) and plans to buy eight more this year. The agency pledged to operate an emissions-free fleet by 2035 and achieve net zero carbon emissions by 2045.

The authority uses mostly compressed natural gas buses and aims to phase out diesel buses in 2025, said Andrew Biesterveld, COTA's chief engineer and mechanical officer.

"That's a huge milestone," he said. "Going from diesel to compressed natural gas already achieved a 17% reduction in greenhouse emissions and a 73% reduction in particulate emissions."

Hydrogen power is a less widely used option. SARTA is still the state's only transit agency to take serious steps toward a hydrogen-fueled fleet.

SARTA's hydrogen buses get 7.8 miles per kilogram of hydrogen, compared to 4.8 miles per gallon of diesel. Hydrogen, the price of which has fallen steadily in recent years, is also cheaper than diesel at around \$1.80 per kilogram. And Conrad said the fuel is now easier to find.

"When we started this process, we only received one responsive bid to provide the (hydrogen)," he said. "Now I'm getting sales calls."

The Greater Dayton Regional Transit Authority's use of electric vehicles dates to the 1930s, when it adopted trolley buses connected to overhead wires. While most U.S. cities phased out trolley buses decades ago, Dayton took a different path.

"When the transit system tried to get rid of them at least twice, the citizens revolted," Greater Dayton RTA CEO David Ruzinsky said.

While Dayton's transit authority has no plans to buy electric buses, the agency upgraded the trolley buses to lengthen routes. The vehicles can now detach from overhead wires for short trips.

"Wright State University is about 25 minutes away from downtown Dayton," Ruzinsky said. "Before we used to run diesel buses (to Wright State), even though the trolley went three quarters of the way. Now the trolley bus can take them the whole way."

Cincinnati has 12 electric-diesel hybrid buses and a light rail system, and late last year received a \$12 million grant to, among other things, develop a plan to zero out carbon emissions. Akron's Metro RTA unveiled two electric buses last month, and Cleveland introduced 16 low-emissions buses in January.

Scientists and environmentalists overwhelmingly support electric battery vehicles but are divided on the use of hydrogen as a tool to fight climate change. SARTA uses so-called blue hydrogen, which is procured from natural gas.

A Stanford and Cornell study released last year said hydrogen fuel produces 20% more carbon emissions than fossil fuels because hydrogen extraction requires so much energy.

The study concluded that the money needed for hydrogen extraction is better spent on wind and solar.

The Midwest Hydrogen Alliance, a group of businesses, researchers, and public officials, said the study underestimated the carbon dioxide captured in the hydrogen extraction process and overestimated the odds of methane leaks.

Central Ohio's geography is itself a barrier to public transportation.

"We have relatively flat and cheap land," said Elena Irwin, faculty director for Ohio State's Sustainability Institute. "That led to sprawl."

As the population of Greater Columbus grew, the region's leaders expanded roads rather than public transit. Columbus is one of the nation's largest metropolitan areas without a light rail system, and it's harder to build one when the infrastructure is built to accommodate cars, Irwin said.

"We've made cars too convenient," she said.

COTA's electric buses need to charge for five hours a day and have a 140-mile range, spokesman Jeff Pullin said. The agency hopes to build overhead charging infrastructure that lets buses power up as they travel, Pullin added.

The charging needs and limited range give some transit officials pause.

"They have to be charged, and then you're out of commission," said Ruzinsky, with Greater Dayton RTA.

Ruzinsky said he wants to see other transit agencies work out the kinks before the Greater Dayton RTA buys electric buses.

"The electricity demands during hot and cold periods (when buses run heaters and air conditioning) suck the life out of the batteries," he said. "They're still a ways out there before that technology is perfected."

But the nature of public transportation routes makes electrification simpler, Cooke said.

Transit buses "have a fixed route," he said. "We have a solid understanding of where the buses need to go and what their day looks like."

Environmentalists agree that decarbonizing transit is a positive step, as long as it happens alongside other steps. Electric buses, for example, would be truly emissions free only if they drew energy from a renewable power grid.

Even natural gas and diesel buses can reduce carbon emissions if cities expand transit options and fewer people drive.

"The majority of emissions are coming from single-occupancy vehicles," said Miranda Leppla, director of the Environmental Law Clinic at Case Western Reserve University's

School of Law.

"Making (public transportation) as convenient and accessible and interesting to the general public so they're shifting toward public transit is really, really critical."
